This Standard was prepared by the Joint Standards Australia/Standards New Zealand Committee EL-002- Safety of Household and Similar Electrical Appliances and Small Power Transformers to supersede AS/NZS 60335.2.79:2012 three years from the date of publication.

The objective of this Standard is to provide manufacturers, designers, regulatory authorities, testing laboratories and similar organizations with safety requirements designed to give the user protection against hazards that might occur during normal operation and abnormal operation of the appliance and which may be used as the basis for approval for sale or for connection to the electricity supply mains in Australia and New Zealand

The text of IEC 60335-2-79 Ed 4, prepared by IEC Technical Committee SC 61J, was submitted to the Standards Australia/Standards New Zealand Combined Procedure (dual public comment and committee vote) for adoption of the IEC standard as a Standards Australia/Standards New Zealand joint standard.

The principal changes in this edition as compared with the 2012 edition of AS/NZS 60335.2.79 are as follows (minor changes are not listed):

- the standard has been revised editorially to avoid misunderstandings;
- the document has been revised for the consistent use of definitions throughout the text;
- correct references were added in the foreword;
- Annex B has been revised and updated;
- Clause 15 has been revised and updated; clarification of relevant liquid tanks has been added;
- in Clause 20 the revised temperature has been inserted;
- the text in 29.1 was modified in order to remove any misunderstandings and is in line with AS/NZS 60335.2.102.

This Standard is an adoption with national modifications of the fourth edition of IEC 60335-2-79, *Household and similar electrical appliances – Safety – Part 2-79: Particular requirements for high pressure cleaners and steam cleaners*. It has been varied as indicated to take account of Australian and New Zealand conditions.

This part 2 has to be used in conjunction with the latest edition of AS/NZS 60335.1 Household and similar electrical appliances – Safety – Part 1: General requirements and its Amendments. It was established on the basis of AS/NZS 60335.1:2011.

This part 2 supplements or modifies the corresponding clauses of AS/NZS 60335.1 so as to convert it into the Australian/New Zealand Standard: Safety requirements for high pressure cleaners and steam cleaners.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text of Part 1 is to be adapted accordingly.

NOTE 1 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.;
- subclauses, notes and annexes that are additional to those in the IEC standard are prefixed with the letters AZ.

NOTE 2 The following print types are used:

- requirements: in roman type;
- *test specifications: in italic type;*
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3.

p NOTE 3 In this document, p is used in the margin to indicate instructions for preparing a consolidated version.

The essential safety requirements in AS/NZS 3820¹ that could be applicable to requirements for high pressure cleaners and steam cleaners are covered by this standard.

The national variations to IEC 60335-2-79 Ed 4 form the Australian and New Zealand national variations for purposes of the IECCE scheme for recognition of results of testing to standards for safety of electrical equipment (the CB scheme).

INTRODUCTION

It has been assumed in the drafting of this International Standard that the execution of its provisions is entrusted to appropriately qualified and experienced persons.

This standard recognizes the internationally accepted level of protection against hazards such as electrical, mechanical, thermal, fire and radiation of appliances when operated as in normal use taking into account the manufacturer's instructions. It also covers abnormal situations that can be expected in practice and takes into account the way in which electromagnetic phenomena can affect the safe operation of appliances.

This standard takes into account the requirements of IEC 60364 as far as possible so that there is compatibility with the wiring rules when the appliance is connected to the supply mains. However, national wiring rules may differ.

If an appliance within the scope of this standard also incorporates functions that are covered by another part 2 of IEC 60335, the relevant part 2 is applied to each function separately, as far as is reasonable. If applicable, the influence of one function on the other is taken into account.

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

An appliance that complies with the text of this standard will not necessarily be considered to comply with the safety principles of the standard if, when examined and tested, it is found to have other features that impair the level of safety covered by these requirements.

An appliance employing materials or having forms of construction differing from those detailed in the requirements of this standard may be examined and tested according to the intent of the requirements and, if found to be substantially equivalent, may be considered to comply with the standard.

HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

Part 2-79: Particular requirements for high pressure cleaners and steam cleaners

1 Scope

This clause of Part 1 is replaced by the following.

This part of IEC 60335 deals with the safety of high-pressure cleaners without traction drive, intended for household and commercial indoor or outdoor use, having a **rated pressure** not less than 2,5 MPa and not exceeding 35 MPa.

It also applies to steam cleaners and those parts of hot water high pressure cleaners incorporating a steam stage which have a capacity not exceeding 100 l, a **rated pressure** not exceeding 2,5 MPa and a product of capacity and **rated pressure** not exceeding 5 MPa·l.

They are not equipped with a traction drive. The following power systems of the drive for the high pressure pump are covered:

- mains powered motors up to a **rated voltage** of 250 V for single-phase machines and 480 V for other machines,
- battery-operated motors,
- internal combustion engines,
- hydraulic or pneumatic motors.

This standard does not apply to

- high pressure water jet machines having a **rated pressure** exceeding 35 MPa;

NOTE 101 In Europe, those machines are covered by EN 1829-1.

- steam cleaners intended for domestic use (IEC 60335-2-54);
- hand-held and transportable motor-operated electric tools (IEC 60745 series, IEC 61029 series, IEC 62841 series);
- appliances for medical purposes (IEC 60601);
- agricultural sprayers (ISO 4254-6);
- non-liquid, solid abrasive cleaners;
- machines designed to be part of a production process;
- machines designed for use in corrosive or explosive environments (dust, vapour or gas);
- machines designed for use in vehicles or on board of ships or aircraft.

NOTE 102 Attention is drawn to the fact that in many countries additional requirements on the safe use of the equipment covered can be specified by the national health authorities, the national authorities responsible for the protection of labour, the national water supply authorities and similar authorities.

2 Normative references

This clause of Part 1 is applicable except as follows.
